I. Data Controller

II. Personal Data Collected

AliBio collects your personal data directly, when you provide it through our contact channels, forms, website, or any other digital or physical means. The personal data we may collect includes, but is not limited to:

III. Purposes of Processing Personal Data

IV. Transfer of Personal Data

AliBio commits not to transfer your personal data to third parties without your consent, except as provided under Article 37 of the Law, and to carry out such transfers under the terms established by said Law.

V. ARCO Rights (Access, Rectification, Cancellation, and Opposition)

You have the right to access your personal data in our possession and the details of its processing, as well as to rectify it if it is inaccurate or incomplete; cancel it when you consider it is no longer required for any of the purposes stated in this privacy notice, it is being used for non-consented purposes, or the contractual or service relationship has ended; and to oppose its processing for specific purposes.

To exercise your ARCO rights, you must submit a written request via email to contacto@alibio.com.mx or at AliBio's address. The request must include:

1. Name of the data subject.
2. Address or another means to communicate the response to your request.
3. Documents proving your identity or, where applicable, legal representation.
4. A clear and precise description of the personal data for which you wish to exercise any ARCO right.
5. Any other element or document that facilitates the location of the personal data.

AliBio reserves the right to make modifications or updates to this privacy notice at any time, to address legislative changes, internal policies, or new requirements for providing or offering our services or products.
